In April, **Martin Malloy** is to be invested as President of CILIP in place of **Debby Shorley**, University Librarian at Sussex. Martin is Director of Cultural and Community Services at Derbyshire County Council. **Ian Snowley** will be the new President Elect of CILIP. In February, Ian was appointed Director, Academic Services for University of London Research Library Services at Senate House. For the previous six-and-a-half years, Ian was Director of Information Services at the Royal Society of Medicine.

With the closure of CILIP's consultancy service, there have been a number of departures from CILIP since October, including **Sue Brown**, Deputy Chief Executive, **Tim Buckley Owen**, Head of Membership Marketing and Media, and **David Haines** and **Leonard Latiff**.

In November, **John Dolan** was appointed as Head of Library Policy at the Museums, Libraries and Archives Council (MLA). John was previously Assistant Director, Community Learning and Libraries, in Birmingham.

Steve Morris has been appointed the new Finance and Corporate Resources Director at the British Library.

At the Department of Trade and Industry, **Sally Doxey**, Information Researcher for DTI's Infosource, has been responsible for serials since last August, when **Victoria Mullen** went on maternity leave.

Karen George has been made substantive in the post of Head of Library and Information Team at the Home Office, having been previously on temporary promotion to the post.

At the Office of the Deputy Prime Minister, **Donna Howard** was appointed Publications Contracts Manager in the Information Management Division Collaborative Ventures Branch. Donna, who previously worked in ODPM's Finance Department, then part of IMD, replaced **Alexandra Parr** who was Collaborative Ventures Workstream Leader and has moved elsewhere in the department.

Hannah Powell has been confirmed in post as Library Assistant Acquisitions at the Natural History Museum in London.

Chris Mills has been appointed Head of Library & Archives at the Royal Botanic Gardens, Kew. Chris was previously Head of Collections and Services at the Natural History Museum, where he had been for 13 years. Chris replaces **John Flanagan** who retired in December after 22 years at Kew, and will be seeing through to completion the planned extension to the Library &

Archives and the Herbarium at Kew. This has been designed to allow for a potential 50 years' expansion, and to include a Reading Room area with public access and exhibition space. Building is due to commence this year.

At Scottish Natural Heritage, **Paul Longbottom** joined in January as Library Manager. Paul is involved in co-ordinating the relocation of the library to Inverness. For the previous six years, Paul was at Morecambe Bay Hospitals NHS Trust, most recently as Clinical Librarian.
