On the implementation of the new governance structure at the Chartered Institute of Library and Information Professionals (CILIP), **Caroline Moss-Gibbons** and **Judy Broady-Preston** were both elected as first Leader of the CILIP Council. The Leader's role has been shared for this first year, with Judy as Leader for the first part of the year, and Caroline Leader from the beginning of July. Judy is a lecturer at Aberystwyth University's Department of Information Studies. Caroline, formerly Head of Heritage Collections at the Royal College of Physicians, is now an independent management consultant specializing in electronic resource management and heritage business development.

In April, **Charles B Lowry** was appointed as Executive Director of the Association of Research Libraries (ARL), Washington. Charles is currently Dean of Libraries at the University of Maryland, College Park.
